Information about the Office of Executive Inspector General for the Agencies of the Illinois Governor (OEIG) pursuant to 5 ILCS 140/4.

### **Mission Statement:**

The OEIG is an independent state agency dedicated to ensuring accountability in state government. The OEIG receives and fairly investigates complaints of fraud, waste, abuse, misconduct, and violations of laws or policies, and recommends corrective action. In addition, the OEIG reviews hiring processes for agencies within its jurisdiction. Lastly, the OEIG oversees ethics and harassment and discrimination prevention training for employees and officials within its jurisdiction.

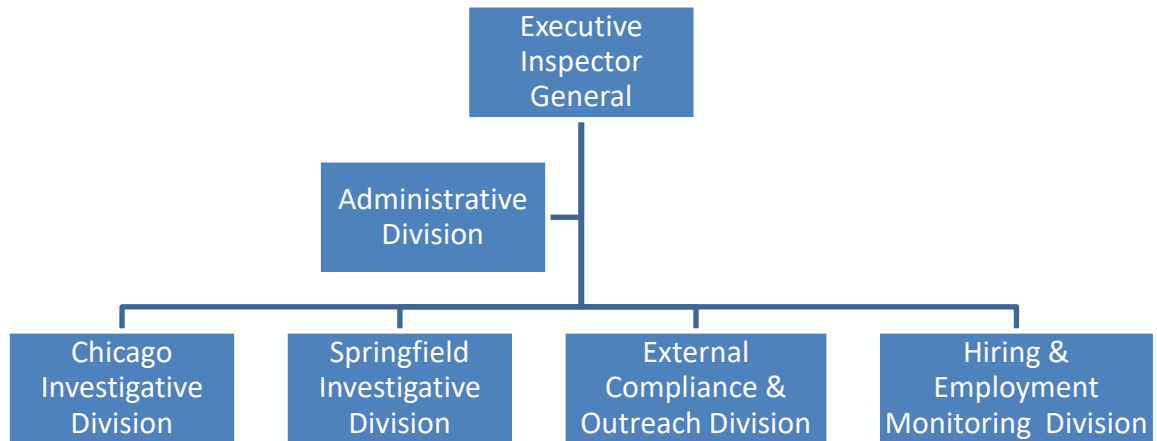
