Recent News

On May 24, 2012, the Executive Ethics Commission publicly released two redacted OEIG final reports and a decision regarding an appeal of an OEIG revolving door determination:

- **In re: Dorian Jones**, 11-00855, involved violations of department policies by a Department of Public Health employee. Mr. Jones received a 10-day suspension.
- **In re: Lawrence Stone**, 10-00228, involved the State Employees Retirement System's Chief Internal Auditor's violation of agency policies. Mr. Stone received a 20-day suspension.
- **In re: Marcia D. Johnson**, 12-EEC-012, the Commission agreed with the Attorney General's appeal, vacated the OEIG's revolving door determination, and concluded that Ms. Johnson was *prohibited* from accepting an employment offer.

The OEIG is pleased to announce the appointment of a new employee:

- **Jeffrey Leh** will serve as Supervising Investigator in Chicago. Mr. Leh is the retired Deputy Chief of a suburban police department and has an MPA from NIU and a BA from WIU.

Legislative Update

During the Spring 2012 legislative session, the OEIG actively supported bills sponsored by State Rep. Fred Crespo (44th District) intended to increase transparency and strengthen State employee ethics training compliance:

- House Amendment #1 to House Bill 4191 would require the public release of founded OEIG investigative reports concerning a loss of public funds of \$5,000 or more; and
- House Bill 4065 would set a minimum \$250 fine for failure to complete mandatory ethics training on a timely basis.

Although both bills made it through the earliest stages of the legislative process, they eventually stalled. The OEIG wishes to thank Rep. Crespo and all Legislative Bill sponsors for supporting our continued effort to promote increased ethics and transparency in State government.
