OEIG Investigates Steering of State Contract

In a founded report recently publicly released by the Executive Ethics Commission, the OEIG investigated allegations that a services contract was

steered to retired Illinois Department of Public Health (IDPH) employee Don Williams by employees at the Health Facilities and Services Review Board (HFSRB) and IDPH. IDPH provides support services for the HFSRB, including the services at issue in this procurement—operation of a particular HFSRB database.

The OEIG discovered that HFSRB Administrator Courtney Avery drafted the procurement specifications to be unduly restrictive, so that Mr. Williams would be one of the few vendors, if not the only one, who could meet them. In addition, the OEIG discovered that then-IDPH Deputy Director Bill Dart and IDPH Public Service Administrator Debbie Magerl were aware of the specification problems, but had failed to take action. Ultimately, the OEIG concluded that Ms. Avery, Mr. Dart, and Ms. Magerl improperly prevented competition in the procurement. The OEIG also found that Ms. Magerl improperly guided Mr. Williams on drafting his resume that was submitted in his bid.

In response to the report, the Governor's Office appointed a Chair to the HFSRB to fill the previously vacant position. Ms. Avery completed training on hiring and procurement. Mr. Williams' contract was voided, and IDPH stated that it intended to counsel Ms. Magerl, and to implement procurement training for Ms. Magerl, Ms. Avery, and HFSRB-associated staff.
